


INVOICE

An Invoice is used to record sales when the customer will pay later. An Invoice contains detailed information about the products and services provided to a customer. If the Invoice is recording the sale of a product, sales tax may be required on the sale. Mookie The Beagle Concierge will charge the customer the sales tax and then remit the sales tax collected to the state department of revenue.






